Pakistan played important role to solve the ties of west and China in 1972. Pakistan tied up with China in broad political and economic ventures, considering that China to be a stabilizer to India and the United States. Pakistan joined the capitalism, government system, in the mid of 1950 .it was not meant that Pakistan will not able to have the relations with china. they will save each other in defensive ways but Pakistan did not support china when she was invading the Tibet due to her violations. Pakistan supported the china in indochina war and resolved their boarder issues in the era of Ayub khan. It is considered a great one good tenure because he introduced good foreign policy with china Pakistan and United States of America. The relations became more and more powerful when united states deny to help Pakistan financially and meanwhile China helped Pakistan to use the airline operating system.

The first era of trade after recognizing the China, Pakistan export the cotton but China denied due to issue of currency. After a short span of time they started the export and import of coal and cotton. Pakistan joined SEATO and CENTO, the security pacts, which were presented by USA to save their regional security issues. At that time prime minister proclaimed to china that we only joined these pacts due to our security reasons and china should maintain its relations with Pakistan without any hesitation.

Pakistan and China have bilateral relations and they supported each other in economic, military and energy sectors like in the indo-Pak war over Kashmir issue in 1965. On the other side UOS put the sanctions on both states but at that that time china helped Pakistan with F-6 fighter and T-9 tanks and anti-craft weapons. Pakistan was also supported by china in UNO over Kashmir issue recently. China has a good record to support Pakistan in regional and international issues. China supported Pakistan to combat the terrorism as well as gave diplomatic support in United Nations over Kashmir issue. China also supported Pakistan in economic and political ways

in the era of 9/11 when USA was ready to attack on Pakistan. China normalized the relation between Pakistan and USA. Pakistan and China started friendly relation in 1950. Pakistan supported the China in China's local matters. Pakistan officially recognized the Taiwan as main land of China. Pakistan and China developed diplomatic ties with China in 1951. The first dispute between Pakistan and China on border issue later this issue was resolved with diplomatic ties. Pakistan gain independence and joined the capitalist bloc and declared that it's not mean to join the capitalist bloc that Pakistan will support the USA. Pakistan will enhance the relations with communist bloc. (Raheel2017).

Pakistan considered the China provided the support to Pakistan and less the Indian influence. India recognized the China and developed the closer relations with China. The Prime Minister of India Nehru plays a pivotal role to develop the diplomatic relation with China. One state that imports all its oil is likely to be more dependent on a continual flow of petroleum than a country importing furs and jewelry will be on continuous access to these luxury goods.

In simple where does mutual relation exist it's called interdependence. There is no limit of interdependence states are interdepending in many ways like economic military as well as agriculture and technology. The former interdependence of USA and Soviet Union this relation converts the thing in doubtful manners like just strong states are interdepending on each other like USA and Soviet Union. Pakistan has an economic power less than China but both states are interdepending on each other. So there are no restrictions about interdependence. Interdependence theory was first introduced by Harold Kelley and john Thibaut in 1959 in their book, 'the social psychology of groups', this book drew inspiration from social exchange theory or game theory. This theory formalized in 2003. A change in the state of any subpart changes the state of any other subpart. Everyone move one member will, relatively speaking deeply affect the others members and state of the group.

Interdependence is a social exchange theory which explains that interpersonal relations defined through interpersonal interdependence which is the process by which influences on another's interacting people experience. All the states interlinked with each other because when you sign an agreement and enhance the relation so it is a norm that states must respect the sovereignty of other states. The first state depends on other second states in economic and political ways. Both state become ready to accept the positives and negatives spillover effect of agreements. OBOR initiatives

OBOR one belt one road initiatives is shortest route to connect with other states. China will play important role to develop the market in OBOR include countries. a lot of infrastructure investment and projects in global and regional level. The dream of president Xi came true in 2013 when he signed (OBOR) One belt one road initiatives mega project. Through it China will gain development, and became nationalist. The grand plan of China builds when China ready to work on market and financial reforms as well as follow the socialist rule of law. China wanted to make her own industry where's all the things have logo that "Made by China". China also have dream to participate in global issues like climate change humanitarian aid. OBOR also called a (BRI) belt road initiatives. According to Chinese media OBOR is a better opportunity for developing state they will stable their economy as well as help to build regional connectivity. In 2019 lot of states wish to become a member of OBOR so 126 states and 29 international organizations ready to invest in OBOR. China is developing the win-win situation in the world. According to rail routes of 2019 China linked with the Yunnan, to Singapore then south Gwadar port to Indian ocean and European or Eurasian rail line of 12,000 km from Yiwu in the Zhejiang Province on China's east coast to arrive at London in 18 days. OBOR will enhance the strategic relations among states. They will easily exchange the things within few days.

Financially, the OBOR called upon several financial institutions to funnel monetary resources. China's domestic financial institutions, the financial pool includes the Silk Road Fund announced by Xi at the 2014 APEC meeting with a pocketbook of \$40 billion and the Asian Infrastructure Bank (AIB) established in 2014 with a startup reserve of \$100 billion. It also includes the New Development Bank (NDB), an institution proposed by the five BRICS states (Brazil, Russia, India, China, and South Africa) in 2012. The NDB became operational in 2015 with a capital investment of \$100 billion. Shanghai Cooperation Organization (SCO) member states China, Russia, and Central Asian countries ready to support the

Imran Khan says that we should build a shorter and better route of the CPEC instead of opting for the eastern route, which will create resentment in other provinces against the Punjab. The recently IMF international monetary fund bailout will only be enhancing the pressures on provincial resources. According to various estimates, CPEC projects will create 400,000 to 700,000 jobs during 2015-2030. At first glance, the labor that is used to work on infrastructure and energy projects is governed by internal labor laws that are poorly implemented. Four energy projects three wind farms in Sindh and one coal-fired power plant in Punjab were commissioned in 2017. Most of our employees are poorly educated and unskilled. Employers and contractors do not enforce safety standards and do not provide worker safety training. It seems that there are no plans to improve and expand education. The literacy rate remained unchanged at 58 percent in 2017, the same as the previous year, while the overall school enrollment rate fell 3 percent. CPEC projects are in the early stages of implementation, and SEZs are in the planning stage. Although there are fewer and weaker unions, there are many union federations, they are affiliated with international federations and have representation in many tripartite bodies. It's time for them to come together to discuss the opportunities and challenges posed by CPEC. The bilateral relations of China and Pakistan will leave a good impact on CPEC. (Hisam, 2017) .In first stage both states enhance their energy sectors and build up the road which will connect with region. The second phase China will invest \$7billion in communications like build highways, railways, and Gas pipelines. Pakistan also signed to build the SEZ special economic zone within the province of Pakistan. (Godement & Kratz, 2015). China enhance the infrastructure and construct the Railway lines energy pipelines routes and also main aim to develop the Gwadar port through it China will invest in different sectors. Pakistan has opportunity to develop her economy and infrastructure to maintain her relations. China helps Pakistan that she will reduce her loan rates through China's help. China will invest \$11 billion CPEC infrastructure. The effects shareholder's will change the wealth of firms of the Karachi Stock Exchange around events leading up to the signing of the China-Pakistan Economic Corridor (CPEC) agreement. The CPEC agreement would be implemented in three phases: the early harvest, medium phase and the final phase, ending in year 2030. The parties to this bilateral contract China and Pakistan could contemplate further enhancements of these agreements, as work on these 46 billion dollar projects progresses, inviting other regional players into the fold such as, Iran, India, and the Central Asia states.

In addition, the CPEC agreement is a subset of China's much larger "One Belt One Road" initiative. The results of our study would surely provide significant evidence on the value of these regional trade agreements and positive impact on OBOR initiatives. It is important to note that the South and Central Asian region is the least connected trade region of the globe. The results of our study should be elucidated with vigilance. Due to unavailability of firm-specific historical data, we were unable to provide a sector wise wealth impact of the CPEC agreement. Moreover, our results could have the large-firm effect bias since the KSE-100 Index is primarily composed of the largest Pakistani firms. (Ghani, 2018)

RESULT AND DISCUSSION
